RULES AND REGULATIONS GOVERNING TRAINEES' CONDUCT

I. SCOPE OF APPLICATION

a) these statutes and codes of conduct are binding upon all trainees enrolled at **Uriri TVC**, irrespective of their mode of study whether in the regular programed, school-based sessions, or short-term modular courses.

II. RATIONALE FOR REGULATORY FRAMEWORK

b) in any structured community wherein individuals coexist while sharing communal resources and common educational pursuits, it becomes imperative to establish a defined framework of conduct. Such a framework ensures the protection of individual rights while promoting a harmonious, orderly, and ethically guided coexistence.

III. COMMUNITY ETHOS AND ASPIRATIONS

Uriri TVC comprises a collective of adult learners and institutional leadership, who are mutually obligated to uphold the outlined regulations. These principles are intended to foster personal growth and elevate the overall standards of communal living and academic engagement.

IV. INSTITUTIONAL VISION

Uriri TVC is steadfast in its pursuit of academic and professional excellence, supported by a cadre of proficient trainers and well-furnished instructional facilities designed to achieve these aspirational benchmarks.

V. TRAINEE RESPONSIBILITY

All trainees are enjoined to actively contribute to the realization of the institution's mission by preserving the institutional integrity and continually enhancing the standards of professionalism. A trainee, as a member of this community, must safeguard college property and exemplify exemplary conduct in morality, personal hygiene, diligence, and decorum.

1. SPECIFIC RULES AND REGULATIONS

a) Smoking

Smoking is categorically prohibited within any precincts of the college.

b) Narcotics and Prohibited Substances

The possession, distribution, handling, or consumption of narcotic substances or any illicit drugs constitutes a criminal transgression and is subject to legal prosecution. Such conduct is unequivocally forbidden.

c) Alcoholic Intoxicants

Possession, handling, or consumption of alcoholic beverages within the campus is strictly proscribed. Trainees found to be under the influence of alcohol to a degree that impairs their comportment shall face disciplinary action.

d) Class Attendance

Attendance at all instructional sessions and scheduled academic activities is **compulsory**. Punctuality shall be strictly observed. Authorization for absence not exceeding five instructional periods may be granted by the relevant Head of Department. Absences surpassing this limit must be formally approved by completing the requisite Leave of Absence Form, obtainable at the Dean of Students' Office.

e) Assault

engaging in acts of physical aggression constitutes a criminal offense and is expressly forbidden within the college.

f) Bullying

any manifestation of bullying whether physical, psychological, verbal, racial, religious, sexual, disability-related, or cyber in nature is absolutely prohibited and shall be dealt with in accordance with institutional and legal provisions.
